REPORTS

Milwaukie Police Department

David McVeigh, MPD K-9 handler & Officer announced Benz, K-9 Officer recently made an arrest and the felon received a 5 year sentence. The department purchased K-9 Officer Benz a ball and two drones which will aid in accident scenes, apprehending suspects who are running from officers and other K-9 work. Officer McVeigh noted a new revised citation system is in use and body cameras have been purchased. The departments goal is to have body cameras operational and in use by July 1st. It was announced that a Prescription and Shred Day will be held on Saturday, April 30th from 10 am to 2 p.m. at the Milwaukie Public Safety Building.

Officer David McVeigh will get report back to us in regards to the replacement of a yellow flashing speed sign located on the S.E. 43rd & Where Else Lane island. Carla Benz commented about the recent car break-ins on S.E. Pennywood. Officer McVeigh will do drive through checks in this area.

TREASURER

Susanna Pai, Treasurer reported the current balance in our treasury is \$10,261.50. She also mentioned that \$2,968.75 must be allocated before the end of May. In reference to the Bowman Brae plant sale, Susanna noted 73 items were purchased and there were 8 free plants.

PSAC

Christine Giatti, PSAC Representative, noted there were few updates available. The public's feedback In regards to the Harvey Street Project is being requested by April 11th and no later than the end of April.

LAND USE

Paul Hawkins, Land Use Representative, reported no new construction.

GRANT REQUESTS

Milwaukie Environmental Stewards Group

Pamela Denham, Treasurer of the MESG, is requesting a grant of \$500.00 from each of the NDA's. She noted there is about 3.5 people that are working on having a Sustainability Fair, on Saturday, September 17th from 2-6 p.m. Approximately 500 attendees are expected. Pam also mentioned a new website will be available for the Milwaukie Environmental Stewards Group.

The \$500.00 will defray costs of our event such as equipment, rentals, porta potties, etc. The fair's mission is to focus on our goals of replacing single use products with reusable practices and sharing this Information with all citizens of Milwaukie. Our NDA will vote on this request at the May meeting.

Milwaukie Public Safety Foundation

Sue Richardson, Board Member of the Milwaukie Public Safety Foundation, requested a grant of \$250.00 for the August 27th 9K for K9 Walk. This grant would help support the MPD K-9 Program, replace a retired K-9 Officer, provide food, training and equipment. Our NDA will vote on this request at the May meeting.

OPEN FORUM

Kate Houston, Lake Road NDA contact for the Bowman Brae Park development, provided notes on the 3/23/22 Parks and Recreation Board meeting. Adam Moore, Parks Development Coordinator, noted there is an area of private property about 12X84 feet near Bowman Brae Park. He advised citizens be respectful of this property and enter the park from Bowman Brae Street. The time-line for this park is:

- 1. 1st Open House meeting will probably be held in July
- 2. In October, a public meeting will be held
- 3. Presentation of the final plans will be in November
- 4. Final approval of plans will go to the City Council for approval
- 5. Final designs and meetings in Summer of 2023
- 6. Construction planned in the Fall of 2023
- 7. Construction completed and ribbon cutting completed in Fall of 2024
