It's Time to Move Forward With Construction For Milwaukie Bay Park

At the recent duck race and concert in Milwaukie Bay Park on a hot Saturday evening, many folks commented on the lack of shade and the need for more trees in the park. The 2019 final design for phase 3 of MBP (which you can view at **ncprd.com/milwaukie-bay-park-project**) would include more trees, although still more will be needed as we confront ever-hotter summers.

The Clackamas County Commissioners, acting in their role as the Board of Directors for the North Clackamas Parks & Recreation District (NCPRD), have held up construction of Milwaukie Bay Park for more than three years now out of claimed concerns about making an investment that would not remain in the district. if Milwaukie were to leave. Meanwhile, the cost to build the park continues to escalate and more than \$2 million in state and federal grants are about to expire, if construction doesn't begin soon.

It is time to separate the construction of Milwaukie Bay Park from the question of whether Milwaukie stays in the district. No decision has been made to leave—Milwaukie is seeking legal clarification on the appropriate mechanism to do so, but that is unlikely to be resolved soon. In the meantime, we are willing and eager to work with NCPRD to restart progress for Milwaukie Bay Park.

Moving forward with Milwaukie Bay Park is an equitable move for NCPRD ratepayers, in Milwaukie and across the district, for a number of reasons - here are just a few:

- The new proposed amenities—a nature play area, amphitheater, splash pad and more—would be open for use by all whether they live in Milwaukie, the county or beyond. People already come from as far as Molalla and Estacada to use the boat ramp, or to visit the park after a trip to the farmers market.
- In the 2020 funding agreement, that the commissioners refused to sign, NCPRD was only on tap for about one-third of the funding of the project. Funds from the City of Milwaukie, system development charges paid by Milwaukie residents, and the now-lapsing grants made up the majority of the project budget.
- The bulk of what NCPRD would have invested under the 2020 funding agreement was \$3 million from its Metro bond local share funds. That \$3 million is an equitable expenditure as it equals 20% of the \$15 million currently being spent on phase 1 of the Concord project in Oak Grove. Milwaukie residents are approximately 20% of the ratepayers within

NCPRD, yet NCPRD has built only one park (Wichita Park) in Milwaukie in the past two decades. NCPRD continues to find funding for other projects in the district while ignoring Milwaukie.

• The NCPRD role in Milwaukie Bay Park was minimal prior to the 2017 launch of phase 3 design work. Property was acquired and phases 1 and 2 were built by Milwaukie taxpayers, and through grants obtained by Milwaukie staff.

In sum, Commissioner Paul Savas' repeated claims to be concerned about a "stranded asset" seriously overstate the investment by and risk to NCPRD ratepayers.

The November election ballot will feature two city council—position 1 and 3, which are up for their 4-year election cycle. For those interested in running, be sure to note the following dates:

- May 5: last day to establish residency
- July 29: first day to file nomination papers
- Aug. 27: last day to file nomination papers
- Nov. 5: Election day

Hillside Park Happenings

Situated in the Ardenwald-Johnson Creek neighborhood along SE 32nd Avenue, Hillside Park is an existing public housing community that contains 100 housing units across 13.7 acres.



After years of planning and predevelopment, the Housing

Authority of Clackamas County and affordable housing developer Related Northwest have recently begun the site's redevelopment. Hillside Park's new development is guided by an approved master plan, which calls for 500 new units of housing. The first projects to be completed will bring 275 units of amenity-rich and service-enhanced affordable housing to households with incomes at or below 60% of the Area Median Income.

Below is an overview of onsite construction activities from July, as well as anticipated activities for August:

Construction Activities Completed in July 2024:

- · Demolition and clearing of existing site improvements
- Demolition of existing roads
- Grading started for new roads
- Began undergrounding power and communication lines on 32nd Avenue

Upcoming Construction Activities in August 2024:

- Continue site grading
- · Commence work on sewer and storm lines for first building
- Grading for first building and digging for foundations

Who's a Good Girl? Flora, the MPD's New K9!



The Milwaukie Police Department (MPD) is excited to introduce a new canine resource. Through funding received from the Milwaukie Public Safety Foundation, the MPD has acquired an Electronic Storage Device Detection K9, Flora.

Flora is a 2-year-old red fox lab/golden retriever mix, who is assigned to the investigations division and primarily searches for items in cases requiring the seizure of electronic storage devices. These include cellular phones, removeable memory and other types of electronics designed to store evidentiary data. Flora trains with her handlers several times each day to stay sharp in search techniques. Flora is also certified in outdoor electronic storage device searches, having the ability to locate electronics devices in several feet of moving water. She also has another valuable skill—Flora is a certified service dog who was initially trained to be an emotional support K9 for military veterans.

Flora will work closely with the MPD detective handlers for her primary role in electronic storage device cases, as well as patrol handlers for comfort dog assignments around the community. She will also be available to use her skills with partnering law enforcement agencies around the region as needed. Curious about what Flora is up to, trot on over to Instagram and follow @K9Flora. Cooling Center in Milwaukie



Following a recent stretch of especially warm summers, Milwaukie is partnering with Clackamas County to open a cooling center at the Ledding Library. The city will keep the Ledding Library building open until 10 p.m. during heat

emergencies. When the cooling center is active, the library community room will be open with water, snacks, games and, most importantly, air conditioning.

Everyone is welcome at the cooling center, but people in vulnerable populations, including small children, older people, and anyone otherwise unable to cool off at home, are encouraged to use the space to escape the heat. When the cooling center is open, a notice will be shared through the city's Facebook account and on www.milwaukieoregon.gov.

Library service hours will remain the same. Cooling centers are not residential shelters, and no one will be housed in the library. The city continues to explore options for an overnight warming shelter for winter months. Campfire Safety Tips

Camping season is here, which means more and more people are outside building recreational and cooking fires. Clackamas Fire District #1 encourages everyone to follow these tips to help keep you and your family safe while enjoying campfires this summer:



- Build campfires where they will not spread, away from dry grass
- and leaves. Place rocks in a circle around your fire area.
- Keep campfires small and don't let them get out of hand.
- Keep plenty of water and a shovel nearby to douse the fire when you're done. Stir it and douse it again with water.
- · Never leave campfires unattended.
- Don't let children or pets play near the fire.
- Don't let children add wood or debris to the fire.
- If your clothes catch on fire stop, drop and roll!
