Financial Constraints and Economic Development

After a cold wet winter and spring, summer has finally arrived. Hooray—here comes the sun! Rather than a single theme for this article, I'm going to touch on several topics.

FINANCE

The budget committee and city council recently completed the city's biennial budget. The budget is tight, but Milwaukie is not facing a shortfall like other Oregon cities. Beaverton's deficit is more than \$7 million and Eugene's is more than \$11 million, just to name a few.

The challenge all cities are dealing with is the increasing cost of everything from building materials to staff salaries. State limitations on property tax increases put into place in the 1990s cannot keep pace with current inflationary pressures. The next biennial budget will be much more difficult to balance given these ongoing trends.

ECONOMIC DEVELOPMENT

Just a couple of years ago, the Milwaukie Marketplace was pretty sad with empty storefronts and tenants continuing to leave. In a short time, things have really turned around with the addition of Planet Fitness, New Seasons Market, Ace Hardware and Luna's Ice Cream. The Ace Hardware grand opening bypassed the traditional ribbon cutting for a more relevant chainsaw cutting of a lumber board embossed with the Ace logo, which was very cool. I complimented an Ace Hardware manager on how quickly they got the store renovated and opened. The manager, who has opened many stores, said they have never enjoyed such responsive support from city building inspection and permit officials. Patrick McLeod of the Building Department was specifically mentioned, and he is just one of many talented and dedicated employees we are blessed to have working for our city.

New Seasons spoke with city council about their first couple of months in Milwaukie. In that time, they had 143,000 customer interactions, which blew past their goals. They have already added more employees since opening with most of those being Milwaukie residents. As New Seasons was discussing other store openings, company leadership were reminded not to expect the same success as Milwaukie in all of their openings! Luna's Ice Cream also needed to add staff shortly after opening, providing part-time jobs for local high schoolers. It's so great to see everyone shopping local and enjoying that delicious ice cream!

Enjoy the summer and I hope to see you this month at Porchfest!

Two City Council Seats to Appear on Ballot

The November election ballot will feature two city council—position 1 and 3, which are up for their 4-year election cycle. For those interested in running, be sure to note the following dates:

- **May 5:** last day to establish residency
- **July 29:** first day to file nomination papers
- **Aug. 27:** last day to file nomination papers
- **Nov. 5:** Election day

Transportation System Plan Update Continues

The city continues updating the Transportation System Plan, which is used to guide transportation improvements across Milwaukie. The last major update was in 2008, with a partial update in 2013. Since then, the city has worked to make Milwaukie's streets safer, more interconnected, and more comfortable for those who walk, drive, bicycle or take public transportation. The Transportation System Plan also helps fulfill other city plans and is required for many types of state and federal funding. City staff have been working with an advisory committee, jurisdictional partners and community members since fall 2023 on the update, and are currently about a third of the way through the project. In July, city staff will share two more pieces of the project under development as part of the Transportation System Plan process. Recent changes to state rules require the city to analyze how its transportation planning efforts are helping the state achieve its goals for reducing climate pollution. Choices need to be made about how to best accomplish this in Milwaukie. The project team has also been working through different types of street designs based on how the street functions, i.e. how much traffic it gets from cars, what are the best streets to improve for cyclists, where do we need sidewalks the most, etc. To learn more, visit the link above. Prevent the Dangers of Summer Heat in Vehicles



As the summer sun beats down relentlessly, vehicles left in its sweltering heat become veritable ovens, posing significant risks to both humans and animals alike. The interior temperature of a parked car can soar to dangerous levels within minutes, even with windows cracked open.

For people, the consequences of being trapped in a hot vehicle can be dire. Heatstroke, dehydration and heat exhaustion are real threats, especially for children, the elderly and those with pre-existing medical conditions.

Animals left in parked cars are also at great risk. Dogs, for example, are particularly vulnerable to heatstroke due to their limited ability to sweat. Even a short period in a hot car can be fatal for these furry companions, making it imperative for pet owners to never leave them unattended in vehicles during the summer months.

To mitigate the dangers of summer heat in vehicles, it's crucial to take preventative measures. Park in shaded areas whenever possible, use sunshades or window visors to reduce interior temperatures, and never leave children or pets unattended in parked cars, even for a few minutes. If you see an animal or child trapped in a hot vehicle in the city, please contact the Milwaukie Police Department at 503.786.7500 to do a welfare check. Oregon law does allow community members to take action in extreme situations, however, community members are encouraged to enlist police assistance first. The Milwaukie Police Department takes heat safety seriously and will respond to these requests promptly.

City Opens New Community Multicultural Events Fund



One of the best ways to bring neighbors together is through shared community events. These can be classes at the library, block parties or citywide festivals, such as the annual Winter Solstice & Christmas Ships celebration. To help continue building camaraderie, the city is launching a new program to help members of the community put on events that celebrate the diversity of the city.

Eligible events must be open to the public at no charge, take place in the city limits of Milwaukie, and must create opportunities for people to learn about and celebrate cultures other than their own. Awards are usually between \$250 and \$2,000 but may vary at the discretion of the review committee.

Applications are due by July 31 and Jan. 31 to events@milwaukieoregon.gov. Applications are reviewed and scored by the Equity Steering Committee, and award announcements are made in August and February. No idea is too small to apply! Fireworks Prohibited in Milwaukie City Limits

As a reminder, community members are encouraged to take note of a code change regarding fireworks. Last year, City Council passed ordinance 2225, which prohibits the sale, possession and use of fireworks in Milwaukie city limits. The maximum possible fine for a fireworks violation is \$1,000. In the past, temporary bans have been placed on the use of fireworks when the risk of wildfires was high. After weighing their potential impacts to veterans, pets and wildlife, as well as the continuing fire hazards they pose to homes and other structures, especially during the drier summer months, City Council decided to make the ban permanent. Community members may notice fireworks stands are missing this summer as well. The new ordinance extends to them, as well as permanent stores and businesses, within city limits.



For those looking to celebrate Independence Day with fireworks, the city encourages community members to seek out public fireworks displays outside of the Milwaukie area. For more information about the new fireworks ordinance, visit www.milwaukieoregon.gov.

New Budget and Fee Schedule in Effect on July 1

Last month, city council adopted the next biennial budget and consolidated fee schedule, which go into effect on July 1, 2024. For more information about these documents, visit www.milwaukieoregon.gov/finance.

The updated fee schedule includes a 3% increase to utility license fees on private electric and natural gas providers that use the public rights-of-way within Milwaukie for their infrastructure.

Why was this increase needed?

- This increase will specifically cover rising costs for police, public facilities and technology improvements. It will also help ensure other general fund services, such as the city's climate and equity programs, can continue.
- General fund revenues have stagnated in recent years and are not keeping up with rising costs
- These fees have not increased since 2016

Generating additional revenue was not an action the city took lightly. In the 2025-2026 biennial budget, the city reduced or held expenses steady wherever possible despite rising service demands. The city also limited other utility fee increases wherever possible—the average city resident's utility bill (water, wastewater, stormwater and transportation) is only set to increase by 0.59%, or approximately \$0.82 per month in 2024.

How will this impact my electric and gas bill?

Typically, electric and gas utilities will pass through some of this increased fee to their customers. Because of this change, the typical residential PGE bill is expected to increase by around \$5.41 a month. The typical residential NW Natural bill is expected to increase by around \$2.77 per month.

Cooling Center Opens in July



Following a recent stretch of especially warm summers, Milwaukie is partnering with Clackamas County to open a cooling center at the Ledding Library. Beginning this month, the city will keep the Ledding Library building open until 10 p.m. during heat emergencies. When the cooling center is active, the library community room will be open with water, snacks, games and, most importantly, air conditioning.

Everyone is welcome at the cooling center, but people in vulnerable populations, including small children, older people, and anyone otherwise unable to cool off at home, are encouraged to use the space to escape the heat. When the cooling center is open, a notice will be shared through the city's Facebook account and on www.milwaukieoregon.gov.

Library service hours will remain the same. Cooling centers are not residential shelters, and no one will be housed in the library. The city continues to explore options for an overnight warming shelter for winter months.
