PROPOSAL: ZONE: R-MD

The applicant is requesting a variance to the maximum fence height standard for fences located in a required front yard (e.g., within 20 ft of the front property line). If approved, the variance would permit the applicant to install a 60-in tall fence, exceeding the maximum 42-in fence height permitted for front yard fences under Milwaukie Municipal Code 19.502.2.B. The fence is proposed to be installed along the front of tax lot 1\$1E35DD05400, which is currently developed with an off-street parking area. The off-street parking area is proposed to be removed and the area revegetated.
