

NOTICE OF PUBLIC HEARING Amendments to Milwaukie Municipal Code

The Milwaukie Planning Commission will hold a public hearing at 6:30 p.m. on Tuesday, January 14, 2025 to consider a recommendation for proposed text amendments to the City's flood hazard regulations (codified in Title 18 of the Milwaukie Municipal Code (MMC)) to establish standards for "no net loss" of key floodplain functions (primary file #ZA-2024-003).

The Planning Commission will hold this meeting both in person at City Hall (10501 SE Main St) and through Zoom video.

SUMMARY OF PROPOSED CHANGES

• Establish standards for "no net loss" of the key floodplain functions of flood storage, water quality, and vegetation.

This proposal stems from requirements passed down from the Federal Emergency Management Agency (FEMA) related to the Biological Opinion concerning impacts of the National Flood Insurance Program (NFIP) on federally listed species protected by the Endangered Species Act (ESA). The proposed amendments are necessary to maintain the City's eligibility to participate in the NFIP while a final implementation plan regarding ESA-NFIP integration is developed by FEMA.

The amendments would apply only to properties in the regulatory floodplain.

If you want to present verbal testimony, either pro, con, or to raise questions, you will be invited to speak following the staff report presentation. Testimony and comments at this hearing must be directed towards the criteria identified. If you submit a written comment or comment in person at the hearing, you will be sent a copy of the decision or recommendation. All written and verbal comments become part of the permanent record.

Failure to raise an issue with sufficient specificity, and accompanied by statements or evidence sufficient to afford the responsible parties an opportunity to respond to the issue, will preclude any appeal on that issue to the Land Use Board of Appeals (LUBA).
