NOTICE OF PUBLIC HEARING Amendments to Milwaukie Municipal Code

The **Milwaukie Planning Commission** will hold a public hearing at 6:30 p.m. on **Tuesday, January 28, 2025** to consider a recommendation for proposed Municipal code text amendments removing the prohibition on variances to maximum residential density (Primary File #ZA-2024-002). This is related to Oregon Senate Bill 1537.

The Planning Commission will hold this meeting both in person at City Hall (10501 SE Main St) and through Zoom video.

The public may participate in this meeting in person or by joining the Zoom webinar. The public may watch live on the city's YouTube channel or Comcast Cable channel 30 in city limits.

SUMMARY OF PROPOSED CHANGES

- Remove the prohibition on variances that would have the same effect as increasing the maximum permitted density for a residential or mixed use zone. This would allow residential developments to request a Type III variance to allow the development to exceed maximum density.

comment or comment in person at the hearing, you will be sent a copy of the decision or recommendation. All written and verbal comments become part of the permanent record.

Failure to raise an issue with sufficient specificity, and accompanied by statements or evidence sufficient to afford the responsible parties an opportunity to respond to the issue, will preclude any appeal on that issue to the Land Use Board of Appeals (LUBA).
