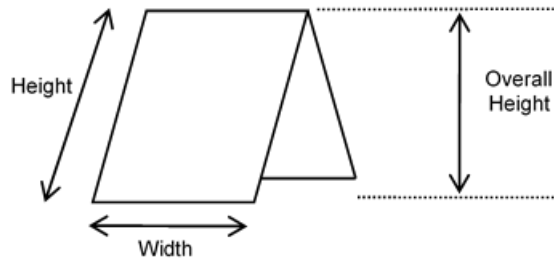
SUBMITTAL REQUIREMENTS:

Staff can provide a scaled aerial photo of the site upon request.

3. The application will be reviewed for compliance with the following standards:

- A. Clear Vision — Daily display signs must not obstruct driver or pedestrian vision at driveways or intersections.
- B. Public Sidewalks — Daily display signs must leave at least 5 ft of width for pedestrian traffic on the sidewalk. *If applicable, the site plan should demonstrate that this standard is met.*
