5:45 – 6:00 Potential Furnberg Improvements Linwood NDA & Staff

Presentation for Furnberg Shelter from Greg Hemer and Pam Husband from the Linwood NDA. The Linwood NDA has funds that they would like to spend towards a covered picnic shelter at Furnberg Park. They have identified water and power available for shelter; however more information needs to be gathered to determine if the shelter will have these amenities. In the past the Linwood NDA has provided funding to NCPRD for other efforts such as the Linwood school track which was a successful project. They explored and assessed projects within the NDA starting with 13 project ideas which led to 864 votes, Majority were to improve Furnberg Park. Additional surveys informed shelter needs. Preliminary shelter costs were identified ~\$68,000 for shelter; Linwood has \$7000 to seed this for the next two years.

The Linwood NDA's goal is to receive support from PARB, City Council, NCPRD, DAC, and others for shelter for Furnberg. Milwaukie Parks Foundation approached the City Council on where to focus, recognizing that Furnberg (as well as Water Tower Park) would be on the list.

Discussion included the shelter features, potential costs for the shelter, funding options, timing, and Milwaukie Parks Foundations as a way to support and considerations for capital project request for Dec 15th to NCPRD "Budget Proposal Form".

PARB does not have funding to support; looking at process on how we engage; recommendations and support is advised from PARB before bringing to other groups

Gary expressed concerned with this impacting Milwaukie Bay Park focus

Heather motion for Subcommittee for Heather & Max to gather more info with Linwood NDA; Virginia second, all in favor

Artist was selected, concepts were provided, extended timeline to work with the artist installation until end of March. Permitted and constructed separately from existing work. This will be led by the art committee and their liaison. Informative presentation to be held at a future PARB meeting.
