III. REPORTS

A. Clackamas County Fire Report Jack Tanz

- Increase in incidents last month in comparison to 1 year ago (likely due to weather event)
- 5 of community fire-stations have increased staffing.
- 24/7 will begin this summer
- New academy starting due to Levi approval
- Safety message this month is Bicycle safety
- Wear a helmet, bright lights—white in front and red in back, as well as bright clothes
- Stay off your phone!!
- Go the same direction as traffic—More than 40% hospitalized with hip fractures do not get to go home—keep awareness of your surroundings

B. Milwaukie Police Report—Tony Cereghino

- Officer Tim Cleary has been released from field training and is now on his own.. This is an exceptionally long process. From Interview to background, to hiring , back police academy and then a 3-4 month FTEP. This all equates to about 16 months of work to be able to be released onto his own for solo status.
- Each phase of training is about 1 month long—phase 5 is the last phase that the recruit has the capacity to manage all resources available to get necessary answers
- 1/26/23-Wilda parks was given a lifetime Achievement award for all that she has done with the City
- Chief Strait has his retirement date set for 4/5/24
- 4 or 5 candidates will be interviewed for new Chief
- Milwaukie Police continues to work with the Providence leadership team to attend to release of person's experiencing houselessness—What does it look like to assist people

who are released to figure out how to partner with City and Hospital to better serve the community.

- Police department is in the works to get an electronic-sniffing dog-Public Safety Foundation is funding this program
- Internet Crimes Against Children-Katherine Myer is working on becoming certified through FBI to attend to this particular predatory
- This dog assigned to the detective division to help the county and state as needed
- Will also be considered a therapy dog (black lab) for traumatic situations as well
- In 12-18 months, officers that are interested in being K-9 handlers will be able to begin the k-9 program again
- Fentanyl is present in almost 90% of drugs that are confiscated
- Detectives just started working a drug house investigation in the City

C. Capital Improvement Plan Projects Jeff Tolentino

- Storm water pipeline project in Ardenwald district by spring water corridor—heavy work is started and underway—another segment by pond will begin shortly
- Hillside phase 1—Hillside development is renovating their houses; Will begin in April
- Ardenwald North—Roadway improvements on north end of 29th, Van Water, and several other streets in that area are in the final stages of design with construction beginning in summer of 2025
- Request by Elvis to have signage added next to Van Water on 29th area
- Manual For Uniform Traffic Control Devices is the standard for City Design and Intersections throughout the U.S.A—(MUTCD was recently updated)
- While Council is reviewing the 29th street situation, likely having 4-ways stop sign might be the actual solution. Meeting is on 3/5/24
- A “Warrent” is a set of checklist from the MUTCD
- City is interested in taking 40th and Harrison to the next safety level, but not clear what that will be at this point.
- Harvey St Open house is set for Spring
- East Monroe Greenway—Design Survey just finished; Open house on 2/29/24 combined with ODOT OR 224 work that is being done as well (council chamber on 3rd floor at city hall)
- King Rd review has largely finished
- Washington St. is ready for construction—waiting for contractor to finalize schedule (end of March/ early April)
- Kellogg Creek restoration project is looking at design in next couple months
- Sediment testing will come over the summer—May be noisy for residents around the reservoir area east of Furnberg park
- Open House in May for Waverly Heights design discussion
- Waverly South is largely a private inlay project with ADA ramp construction with design survey team out in March
- ADA ramp upgrades in Ardenwald neighborhood-around Oleson
- 2024 grind and Inlay project for summer (June/July)—Look for project webpage update in the spring
- Email engineering@milwaukieoregon.gov for recommendations of streets that need a grind or inlay option

Emergency Management Coordinator—Dan Harris

- Natural Hazards Mitigation plan has moved on to the Oregon Office of Mitigation, and then it will go on to FEMA
- One of the action items that came out of this was to look at shelter sites in Milwaukie for the Red Cross to set up shelters
- Red Cross is looking at a few potential shelter sites.
- Ann will be visiting with PSAC in March to discuss ongoing shelter grant
- County is in process of developing a 23 hour stabilization shelter—Designed to help someone who is having a mental health crisis leading to behavior issue; would be staffed by a private contractor who is hired by the county
- This is the former Women's correction center next to the OLCC—Looking at 8 beds on behavioral side, and then 13 beds for 30-60 day housing stabilization.
- Has there been identified areas to move debris in the case of Natural Disaster
- In the process to develop an intergovernmental agreement to handle debris removal.

III. REPORTS

A. Clackamas County Fire Report Jack Tanz

- March 2024: 2,587 incidents: noticeable increase in EMS calls compared to last year at this point.
- 2023 total call volume: 30,132 / 2022 total call volume: 27,975
- This year call volume increased by over 2,000. Over half of this is a result of the contract for service with Sandy.
- Otherwise, there is an overall increase in EMS and fire incidents as well.
- Upcoming Events:
- Open House and Woody Debris Collection Day: Saturday, May 4th at the Beavercreek Fire Station #10. The debris collection is most of the day but the Open House is only from 10am-12pm.
- Other District Info:
- A new hire academy of 10 firefighters began in April. This academy is to further support and enhance response within the community related to the levy approved in 2023.
- Backyard burning opened on March 1st for those outside of the DEQ burn boundary. DEQ makes the decision daily to allow burning or not and the allowed burning hours based on air quality. This is why citizens should ensure it is a burn day prior to doing any backyard burning. The Fire District does not make the decision on what are burn days or not unless there is a fire danger concern. For daily burn information, visit our website or call 503.742.2945.

- Noteworthy incident:
- On April 10th, firefighters responded to a water rescue at Meldrum Bar Park with reports of a victim trapped in a vehicle that had gone into the water, but the driver exited the submerging vehicle and was struggling in the water.
- E315 arrived first on-scene. From the time E315 arrived, located the driver, and pulled the driver out of the water was three minutes. Thanks to your support of the levy, your firefighters from Station 15 in Oregon City received an increase in staffing that went into effect in January 2024. This increase in firefighter staffing saved the driver's life.
- Safety Message:
- This month the Fire District safety focus is on wildfire prevention and preparedness.
- Ensure residents have defensible space around their home, limited ladder fuels, and have combustible vegetation away from their homes.
- Please sign up for the Clackamas County's public alert notification system. (Found on the County website)
- Ready, Set, Go for wildfire and general evacuation warnings:
- o Level 1 - Ready: Have a plan in place and understand what you would take with you when evacuated. Be aware, prepare and stay informed. This is the time to prepare and be ready to evacuate. Older adults, people with special needs, or mobile property owners should take action early. Consider moving pets and livestock early.
- o Level 2 - Set: If told to be prepared to evacuate, have what you need loaded and ready to go at a moment's notice. Be ready to leave with little notice and relocate to a safe place outside of the affected area. You will have limited time to gather necessary items and it may become unsafe to do so.
- o Level 3 - Go: Evacuate now! Leave immediately! It is unsafe for you to stay in the area. This will be the last notice you receive until officials declare it is safe to return to the area.

B. Milwaukie Police Report—Tony Cereghino

- Series of Police Department Administration Promotions has taken effect
- Cert will be helping out with the Drug Turn in (10-2) and Shred Event
- Starting to improve on Staffing—Carlos Martinez 4/22 hire; will be headed to academy
- Alex Beglow—Officer is graduating out of the Academy as new officer
- Will be rejoining the Tri-met transit police giving us an extra officer to help out with special events—Melissa is Bi-Linqual and will be taking this position
- On 99E and 22nd 4/9/24—Pedestrian ran across street into traffic and was struck and led to fatal accident—While it is true that when the person crossing the street was hit; there was a houseless person who came and stole the deceased cell phone!
- Brad Walter (officer and former Marine)—Started a fund for Veterans on the Streets; While waiting for assistance from the V.A. Veterans are able to apply for funds to help them get out of their immediate situation to transition to help from Gov't.
- This year's breakfast fundraiser will have vintage military vehicles, post-legion bikes on display—Event will be on 5/18/24 9:00am-1:00pm at Legion
- Crime in the county and in Milwaukie has an increase in the theft of Kias—Lock doors, and keep valuables out of plain view as a deterrent.
- Another police officer has just been added to the crash team (able to reopen roads within 2 hours): Carl Dorman has been through 3 classes, and is the initial expert to reconstruct the accident. Also using Drones to plug into these programs to get the streets back open
- Incidents with Bicycles has increased:
- For People who own drones, one can get an F.A.A. recreational license to know limits of what is permissible
- Police Department now has an F.A.A. certificate that allows department to follow rules to fly drones individually with the department
- M-30 and compact small ones are currently at department

- Don Holden from Loved one and Glen with Police department work together to house people who are struggling with mental health—**From 10:00am-2:00pm on Tuesdays** are at Library for resource center for people who need direction and assistance.

C. Capital Improvement Plan Projects Jeff Tolentino

- Mink Street storm pipeline project from Harrison to south of Springwater corridor—
- Pond by Kelvin
- Stormwater Pipeline installation to add capacity to city and promote more effective drainage—Impacts to neighbors in the Ardenwald Neighborhood (between June and August) —will be excavators accessing roads of Kelvin, Olsen, Malcom, Boyd, Roswell (May be trucks). Working during daylight hours.
- Hillside is another project in town—Clackamas Housing Authority. Construction has begun (mostly demolition through the summer) Some right of way improvements with that
- Ardenwald North—In Final phases of design. Procurement is for winter with build in summer of 2025
- Harvey Street is 60% complete—Hector Gomez is now project manager
- Logus sidewalks, 49th to 43rd—related to shortfalls and getting funding for Stanley—Design has been moved to 2026, with construction in 2028.
- North Stanley from Johnson Creek-King will receive Full Sidewalks
- King Rd. Improvements %60 design
- Washington Street improvements projects is under construction (23rd-27th is done)
- Installing storm on Madison between 30th-31st
- 27th Street sidewalk upgrade
- Project will continue until March 2025
- Kellog Creek Restoration Project run mostly by ODOT
- 5/9 open house for Sewer Re-alignment at Waverley Heights
- 2024 Grind and Pave is currently in Procurement
- Monroe Greenway is still active—
- 29th Street Ave—Currently reviewing signs that might be applicable and available for the city to provide. After the Slurry Seal, there will be a green trail crossing installed along the greenway-Kelvin, Olsen Malcolm, Boyd, Roswell are streets that would receive marking
- This information will be presented to council in next session
